Expressions of interest are being sought from ten early childhood services across Victoria interested in participating in a unique professional learning opportunity focused on enhancing Road Safety Education in a place-based context.

The Road Safety Inquiry Project 2021 will support lead educators to undertake a local Road Safety Inquiry Project that aims to deepen understanding of road safety education in early childhood and explore meaningful and innovative ways to respond to local safety issues in your community. At the same time your participation, with your colleagues, will assist the Starting Out Safely team to explore and refine our approach to supporting educators in this important work.

Priority will be given to services who indicate that they have identified challenges in relation to children's ongoing safety on local roads, including as pedestrians, cyclists and passengers. Examples could include a challenge with a tricky carpark, access to the community across a busy street, or a recent incident involving a child or family.

What is involved:

The project spans 6 months from January to August 2021 and includes:

- Attendance at 5 professional learning opportunities both online and face to face
- Implementation of a local action research Road Safety Inquiry Project (with support)
- 6 hours of consultancy support from one of the amazing Starting Out Safely Consultants
- And \$1000.00 funding package to support the implementation of the project
- Sharing your finding with your colleagues

Preferred participants in the project should be Lead Educators who can influence practice across the service such as educational leaders.

Applications are required to be endorsed by the Approved provider.
